BOYENKO – Requested administration to research into ownership of siren/fire alarm located at McPhee Lake. Will need to set up meeting with Public Works Manager to review several maintenance issues. Will be attending the annual meeting of the Elk Ridge Estates.

At 10:30 A.M., Cliff Wilson from Amec Infrastructure attended the Council meeting to review possible options for the reconstruction of the South end of Carwin Park Drive. Projected costs were reviewed with emphasis on resolving drainage issues in the area and widening the road as well. Public Works Manager Ernie Locke will be contacting adjacent landowners to review possible options and report back to Council on recommendations for 2016.

At 11:00 A.M., John and Karen Bosker and Stephen and Wendy Olde attended the meeting to present alternate options for a proposed drainage project at the Bell's Beach subdivision. A proposal for a 3 inch bored line (approximate length 110 meters) to accommodate water flow to a public reserve was presented by Stephen Olde. Additional presentations were made by Wendy Olde and Karen Bosker regarding the devaluation of property values relating to the District's preferred option of a swale between the two private properties. Also in attendance were Al Keller and Ron Crush from the Water Security Agency as well as Cliff Wilson from Amec Infrastructure Consulting Engineers.
