#### **ADMINISTRATION REPORTS**

PUBLIC WORKS – Public Works Manager Ernie Locke presented a written report to the Council. Discussion centered on the placement of sand on Bell's Beach; reclamation of the public beach area at Spruce Point; improvements to the recycling drop off areas within the municipality to improve aesthetics and visual appearance; Cuelenaere road access onto Highway #263.

<u>ENFORCEMENT & PROTECTIVE SERVICES</u> – A written report was presented. Discussions centered on ATV issues around the lake and enforcement for non-compliance of the District ATV bylaw. Some questions from the Council as to the enforcement of above ground sewage and grey water disposal as the District works towards an environmentally friendly lake management plan. A recommendation was made for the hiring of a new Special Constable – Curtis Cyr for a term position of 6 months.

Reeve Al Christensen declared the Public Hearing open at 10:04 A.M. as it pertains to the District of Lakeland OCP amendments, the Neis Beach Ltd. discretionary use development proposal and the new OCP for the Village of Christopher Lake. One written proposal was received in favor of the Neis Beach development proposal and no other comments were received regarding the remaining bylaw amendments. No presentations were made or received at the Public Hearing. Reeve Christensen declared the Public hearing adjourned at 10:07 A.M.
