But for incidents occurring within the Lakeland area, the District of Lakeland offers online reporting and local dispatch for your convenience. Report the incident online or call dispatch at 982-4466 to report stolen property, mischief, damages, and other non-emergency incidents.

Who do I call?

We have received some questions, feedback and frustration on who to call for a variety of violations. We hope this helps you to make that decision.

A crime in progress, fire, or emergency should be reported to 911.

LDPS is able to respond to a variety of calls for service.

We are tasked with the enforcement of municipal bylaws for the District of Lakeland. This includes but is not limited to:

- animal complaints regarding cats or dog
- fires during a fire ban
- noise complaints
- unsightly or dilapidated property
- grey water and sewage dumping
- parking

We will respond as we can to emergency calls relating to most provincial offences, and some federal offences. This is an initiative started in the province to allow closer officials to be on scene in a shorter amount of time. This may include traffic related offences like speeding, manner of driving, alcohol/drug use, trespassing, and ATV use, alcohol violations like drinking in public, minors possessing beverage alcohol, and illegal cannabis use.

While we can't tell you who to call, most calls for service can start with the RCMP. If you call our office and the call is to be dealt with by another agency we will forward that call for you.

Please note that when calling our office to report a matter we require you to provide your information to the dispatcher. Anonymous calls, or calls where the caller refuses to leave call back information, including telephone number or name, will not be responded to.



Please be aware of the [parking bylaw](#) for the municipality. Illegally-parked vehicles are subject to being towed away at the owners expense, in addition to any issued parking ticket. Parking in municipal reserves, overnight in designated parking lots, or blocking someone's access are all offences that could result in being towed.

LDPS, along with law enforcement from municipal police services, RCMP, and Ministry of Environment will be conducting several check-stops, and increased enforcement though out the long weekend. An increase in patrols and presence will be seen.

Use seatbelts, make sure those young children are properly restrained. Keep an eye out for slower moving vehicles and machinery.

Protect and Response Team

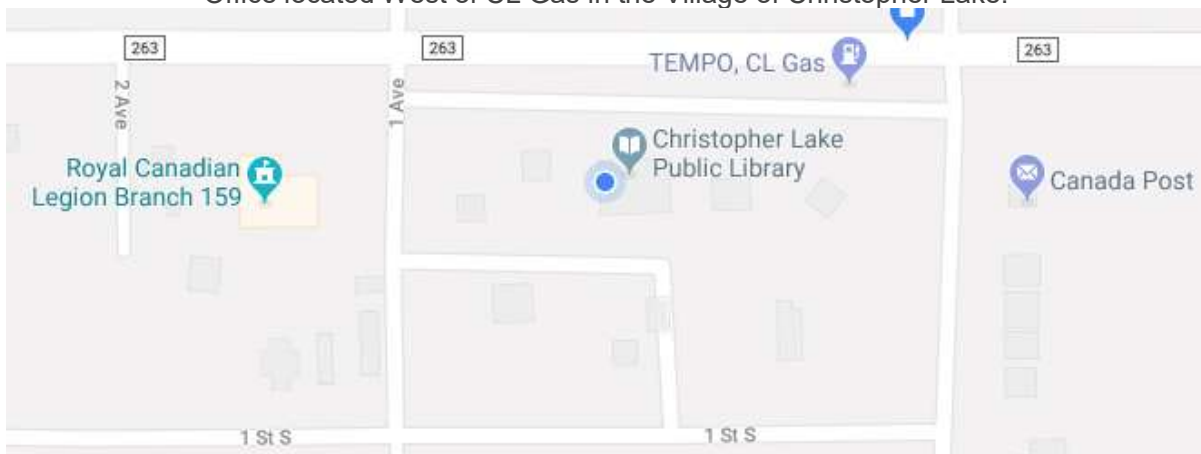
