## 2020 Taxes

Early payment discounts ended on August 31st. A penalty of 1% per month is added until they are paid. You are considered in tax arrears after December 31st, 2020. Taxes are payable by cheque, post-dated cheque, debit card, cash, e-transfer, or through your bank with BMO, Scotiabank, or any credit union. Payments **must** be in our office by December 31st, 2020.

ATV Bylaw: In 2020, a new bylaw was introduced to allow for the use of ATVs on municipal roads in the District of Lakeland. You are still legal to operate under provincial legislation without obtaining a plate with the District of Lakeland, but unoccupied crown land, private land, and alongside highways does not cover municipal roads or Provincial Park trails.
